Pursuant to DA 08-757, the reporting period covered by the instant report only includes one day, March 31, 2008. Nonetheless, this report provides information about voluntary measures taken by the Station prior to the effective date of the applicable rule.

While the above reflects only PSAs and CSTs aired on March 31, 2008, WBBJ aired 399 PSAs between 1 am and 5 am; 43 PSAs between 6 am and 9 am; and 112 PSAs between 5 pm and 10:35 pm Central Time from January 1-March 30, 2008.

The station aired 30 second NAB PSAs ("DTV Answers/Are You Ready") and a locally produced 30 second spot. Text for the local spot: "BY LAW, ALL ANALOG TELEVISION BROADCASTS MUST \*CEASE BY FEBRUARY 17, 2009. TO RECEIVE WBBJ, ABC 7, OVER THE AIR, AFTER FEBRUARY 17, YOU MUST USE A TELEVISION WITH A DIGITAL RECEIVER OR OBTAIN A DIGITAL TO ANALOG CONVERTER BOX AND HOOK IT UP TO YOUR ANALOG TV. IF YOU RECEIVE WBBJ THROUGH A SUBSCRIPTION CABLE SERVICE, YOU DO NOT NEED TO TAKE ANY ACTION. USING A DIGITAL TV RECEIVER OR DIGITAL TO ANALOG CONVERTER BOX, YOU WILL CONTINUE TO RECEIVE WBBJ ON CHANNEL 7.1. FOR MORE DETAILS, GO TO ONE of THESE WEB SITES [display]."
